REGULATION

At every salon will be awarded the FIAP "Best Author" (Special Budget Light Blue)

- 1) Circolo Fotografico Arno, with the sponsorship of FIAP, PSA, ISF, UPI and FIAF, is organizing the International Circuit of Digital Photography Contests: "15° GRAN TOUR DELLE COLLINE", which includes the following events: 29° Trofeo Arno (29th Arno Trophy), 20° Trofeo Città di Figline Valdarno (20th Town of Figline Valdarno Trophy), 9° Trofeo Colline del Chianti (9th Hills of Chianti Trophy) and 9° Trofeo Colline del Pratomagno (9th Hills of Pratomagno Trophy). The contest is open to all amateur and professional photographers worldwide. Entrants must own the copyright to all submitted photographs. The images must have been photographed in every part (even the smallest) by the entrant himself/herself.
- 2) The contest has three themes for "digital" or "digitalized" images, referred to as: A) **Free**, B) **Nature** and C) **Portfolio**. Free and Nature: you can submit up to 4 images per theme; Portfolio (free subject): you can submit between 6 to 10 images. The digital images to all themes must be at least **300 dpi** in JPG; size should be no greater than **1024 pixels** on the long side, in either colour or black and white.
- 3) All entries must be submitted together with an entry form via CD, DVD, or any other digital means, to the following address:

- 4) The subscription fee amounts to € 45 or 65 US\$ or USD 65 (or IRC 65) per entrant, regardless of the category and is valid for all 4 contests. The amount can be forwarded either PayPal made out to Silvano Monchi e-mail: info@arnofoto.it or bank transfer (Poste Italiane): ABI 07601 CAB 2800 c/c n° 56284995, Account Name: Circolo Fotografico Arno IBAN: IT64L076010280000056284995, SWIFT: BPPIITRXXX.
Any entry not accompanied by the subscription fee shall not be admitted and the author of such entry shall not have the right to receive the catalogue of the contest.
- 5) The catalogue, published in book form, shall contain all the winning photos, the minutes of the jury and the list of photographs and participants admitted in the contest.
- 6) Each photograph must bear a code composed of the letter associated with the chosen category (A, B, C) and its progressive number. The title of the photo must be written in the entry form. Photos submitted either through the Internet or by digital means shall not be returned.
- 7) Statistics, minutes of the juries and both winning and admitted photographs will be published in the www.grantourdellecolline.it website and left there until the next edition. All entrants shall receive the results by mail.
- 8) The entrant shall be held responsible in handling any image rights or liberties of the subject matter of the photograph and shall irrevocably consent to the Promoters publishing the photographs, which shall not be used for commercial gain.
- 9) The jury decides exclusively on the admittance of photographs and prize – awarding.
- 10) Though the organizer will attempt to treat all submitted work with the utmost care, the organizer is not responsible for any damage or loss that may occur during the sending of entries, whatever the cause.
- 11) During the operations of the board of judges, a web - cam will be installed and all the filmed material will be broadcast real time on the Internet. The web-site address will be published a few days before the opening of the contest on: www.grantourdellecolline.it.
- 12) We inform you that, according to art. 13 of Leg. Decree 30th of June, 2003, n. 196 (bearing the "Code regarding protection of personal data ") hereinafter abbreviated as the "Code", all personal data submitted to the International Photography contest "14° Gran Tour delle Colline", shall be collected and stored by Circolo Fotografico Arno on paper, electronic and/or mechanical and/or telematic means and appropriately handled in order to ensure data integrity and confidentiality in compliance with the Code. The submitted data will be only used for the purpose of this contest. To this end, the organizer reserves the right to display personal data on the web site of the contest (www.grantourdellecolline.it) and/or publish it in the catalogue. Entrants must submit their personal data to be able to take part in the contest.
In accordance with Art. 7 of Legislative Decree 196/2003, entrants have the right to obtain information, at any time, regarding confirmation of the existence of his/her personal data and their disclosure in an intelligible manner, as well as information related to data processing modalities, update, correction, integration and cancellation of data. The above rights are exercised by means of an informal request to the data controller. The data controller is Circolo Fotografico Arno with registered office in: Via Roma 2, Figline Valdarno – FI (Florence) in the person of its pro-tempore president, Mr. Silvano Monchi.
- 13) Participation in the Contest implies the entrants' total, unconditional acceptance and the acknowledgment of their entire understanding of these Regulations.
